Item 1

New NY Bridge Project Update (0:01:08)

Mr. Shamma presented the item and explained that the first contract with Materials Testing Lab Inc. is for independent referee services for the New NY Bridge and testing and the second contract with HRV Conformants Verification Associates is for testing and inspection of structural steel.

Whereafter, upon motion duly made and seconded, the Major Projects Committee authorized the execution of two testing and inspection term agreements with two firms and authorized its submission to the Authority Board for consideration.
